



### A letter to Lance and Tammy Peterson and the Warrior and Walleye Team

From 23-25 July 2020, I had the extreme pleasure of attending the Warriors & Walleyes Outdoors annual veteran fishing event at Arnesen's Rocky Point Resort on Lake of the Woods in Northern Minnesota. This event caters to veterans across different varying contingency operations and represents all branches of service.

When the event kicked off, I was shocked at the amount of veterans this event entailed. But, what I was even more surprised about was the number of non-veterans that supported roles from volunteering their time to cook food, help with organizing the event, and set up at the site. The boat Captains/Guides are really the people that should be heralded. They take time out of their busy schedules, use their own boats and equipment, and most importantly they use their knowledge of not only catching walleyes, but really big walleyes. I have never seen so many smiling faces!

On 31 March 2020, I retired from the Minnesota Air National Guard after 26 years and am an OPERATION ENDURING FREEDOM veteran. When I retired, I received an American Flag as most retirees do. Until this event, my flag had not been flown. I asked Lance Peterson if I could fly my flag for the event and without hesitation he agreed. I figured it was just going to fly on the flag pole and that would be it. Lance had other plans. He had me get up and tell everyone why this particular flag would be flying and when it came down during retreat, two combat veterans, one of which is a Purple Heart recipient, folded and presented me with the flag. To say it was a huge honor is an understatement.

Being in the military for 26 years and being in the position rank-wise that I was, I had to be observant of the morale of my troops. At the Saturday night supper, I pulled Lance aside and said "Just look and listen". A big smile came across Lance's face and I said "You did this", and we just sat there looking at the crowd of people from veterans to volunteers to captain/guides to family members laughing, smiling and having a fantastic time. If ever there was an example of esprit de corps, this was it!

I thought to myself quite a bit throughout the weekend about values. Although all branches of service were represented at the event, I kept my thoughts to the Air Force Core Values of Integrity, Service Before Self and Excellence. The following is my thoughts and perspective on these values throughout the Warriors & Walleyes 2020 event. Integrity: Lance Peterson made a promise and did exactly what he said he was going to do. Service Before Self: Being a non-veteran, Lance does a more than exceptional job of recognizing and rewarding those of us that gave our all in the name of freedom. He does not want anything else but for veterans to catch fish and have fun. Excellence: Lance has put together a team of people than want nothing less than for this event to be a success. Mission accomplished!

The Warriors & Walleyes Outdoors Board has great vision for this event and keeps the numbers appropriate for attendees. This is an intimate event where almost everyone meets and talks to everyone. No one gets left out of the crowd.

Lance and Tammy Peterson, who honor their childhood friend Stephan Bentzlin who was killed in action on 29 January 1991 in OPERATION DESERT STORM, could not have created a better event. Everyone who attended were gleaming ear to ear with smiles, they told their stories, friends were made, and it is a fun and very well organized event.

#### Paul and Terri Frank Family recognized as a 2020 'U of M Farm Family'

The Paul and Terri Frank family of Wood Lake has been named Yellow Medicine County's "2020 Farm Family of the Year" by the University of Minnesota.

Paul's great-grandfather homesteaded Pleasant View Farm around 1880. The farm began as a diversified livestock and dairy farm. Paul's father decided to focus on raising and selling purebred boars. Paul continued selling breeding stock until 2017, when the family's barns were converted to finish custom feeding. The farm has reached the milestone of having farrowed hogs for 100 continuous years.

In addition to the hog operation, the Franks' farm currently grows corn and soybeans.

Paul and Terri raised three children on their farm, all of whom started working in the fields and barns at a young age and were involved in Yellow Medicine County 4-H. Their daughter Jessica and her husband Tyson have two children. Jessica teaches history at Minneota Public Schools. The Franks' son, Andy, and his wife Ashley have two children. Andy works at Cottonwood Co-op Oil Company as manager of the seed department and farms his own rented acreage. He shares some of the workload with his dad. Paul and Terri's daughter Lisa is married with two children. Her husband, Adam, works on the farm. Lisa is employed by North Star Mutual Insurance.

Paul and Terri are involved in their church, where Paul is council chairman and head elder. Terri was the choir director for 12 years. Paul is currently chairman of the Posen Township Board and served for 12 years as board member of Equity Elevator. Terri served as secretary of the Yellow Medicine County Pork Board.

Though COVID-19 has forced cancellation of the annual Minnesota Farmfest, where the awards are presented each August, this year's honorees will be celebrated in an online video tribute.

Honored families are chosen, one per county, by local University of Minnesota Extension committees based on their demonstrated commitment to their communities and to enhancing and supporting agriculture.
